- Vendor agrees that this fee comes with no warranties of business income and this fee is non-refundable unless sale is cancelled or postponed in which refund would be mailed out within 2 weeks of notification.
- Vendor understands that booth setup is on Thursday, March 22, 2012 between the hours of 9:00am and 3:00pm. Booths are not allowed to be set up past this date and time. Any vendors not setup by the designated time agrees to forfeit their spots and no refunds will be issued. Booths are to be broken down on Sunday, March 25, 2012 from 3:00-5:00pm. Items sold at my booth will only be associated with my business.
- I understand that my booth can be decorated in which ever manner represents my business, and my booth, items, website content, etc. will be family-friendly.
- I understand that I do not have to be present at all times. I can choose to have another person fill in for me, or have a display for the public to see.
- I agree that I will not hold As They Grow liable for any items missing or damaged.
- I understand that I am to provide 250 items such as flyers, coupons, samples, magnets, pencils, or other small promotional items to be included in the bags need to be dropped off Monday, March 19, 2012 between the hours of 9:00am and 8:00pm at the sale location. If your items are not received by 8:00pm on Monday, March 19, 2012 those items will be excluded from the goody bags. I understand that my item(s) cannot be larger than 8 1/2 x 11. IF YOUR ITEM IS 8-1/2 X 11 PLEASE FOLD IT IN HALF.
